

JBM and the JDF have had a long-standing and mutually beneficial relationship that spans over five (5) years and which continues to contribute to National Security and Nation Building.





A practical session was also included where each port employee was given the chance to put their knowledge into practice.



- Commercial Property Tenant meetings with potential tenants were conducted and headed by the Commercial Property Manager, Miss Keisha Schooler. After these meetings, prospective tenants were then reviewed by JBM's internal system: the Tennant Review Committee where applications were reviewed against eligibility criteria and compliance with the relevant policies, guidelines and procedures before a final decision is made.
- The USS Cole vessel, a pillar in Maritime history docked at our pier during the month of July. In 2000, the vessel was the target of suicide bombers who damaged the ship and left 17 sailors dead in Yemen. Later repaired and restored to the US Navy Fleet, the incident contributed significantly to the International Ship and Port Facility (ISPS) Code, a regulatory system that governs all ports around the world. Simultaneously, the first submarine to ever visit our port was docked alongside the USS Cole. These vessels utilized JBM's services including dry docking and the supplying of bulk water and continues to cement our longstanding relationship with international bodies.
- A forecasting meeting was held between JBM and representatives from Worthy Park Estate, Sugar Manufacturing Corporation of Jamaica (SMCJ), and Pan Caribbean where, after rich discussion, it was decided that 4500 Metric Tonnes of sugar was to be shipped from Reynolds Pier, the only shipment for the year. Subsequently, in July a shipment of bulk sugar was sent through our conveyor system into to the vessel MV Balsa 83.
